1.Bulls must be consigned by a breeder from California. Signed registration certificates, completed entry forms, along with a \$100.00 per head fee sent to Turlock Livestock Auction Yard c/o Celeste Settrini 250 Natividad Rd, Salinas CA 93906. No cattle will be cataloged without the \$100.00 entry/processing fee. Entry fees are non-refundable. All entries must be signed by consignors, bulls will not be cataloged without a signed entry. ENTRIES MUST BE RECEIVED BY FRIDAY, AUGUST 23rd (you can choose to email or use USPS however, please allow time as EVERYTHING must be in by midnight on August 23rd).

NO EXCEPTIONS

- 2. The sale management reserves the right to pre-sift entries prior to cataloging. If a bull is pre-sifted, that bull's entry fees will be returned to the consignor. Please have your bulls registered and all weights turned in. We will be looking at that information if a pre-sift is warranted. Consideration will be given to past consignors.
- 3. Sale costs: 6% of proceeds will be deducted for sale commission. Other fees that will be deducted will include brand inspection, beef council, yardage, feed, etc.
- 4. Bulls born between 8/1/22 and 10/1/23 are eligible for the sale. A minimum weight of 1050 lbs. will be required. All bulls must have a minimum 34cm scrotal circumference to be eligible to sell. Consignors or an immediate family member must be the breeder of consigned bulls. All entries must be negative by pedigree or test of AM, NH CA and DD genetic conditions.
- 5. All bulls must be at the sale facility, Turlock Livestock Auction Yard, 10430 North Lander Ave Turlock, CA 95380 by 5:00 p.m. Wednesday, October 2nd.
- 6. Bulls will be evaluated by a select group of industry leaders to determine sale order. Bulls will be evaluated visually and EPD's may also be taken into consideration for determining sale order. All sifted cattle must be removed from the sale facility before 8 am on October 5th.

A supreme champion and reserve champion bull will be selected between all breeds.

7. All bulls must be tagged prior to their arrival. The sale management may check tattoos, be sure and check them before you arrive at the sale. Eartags will be mailed a couple weeks prior to sale day.

- 8. Substitutions will be allowed if legitimate (death, injury, etc.) Please notify sales management as soon as possible if you will be making any substitution. Please advise sales management if you are scratching bulls so that we may have bulls penned accordingly.
- 9. There will be a general floor placed on all bulls to help insure a successful sale. Bulls will not pass through the ring below that amount. That floor amount will be determined by sale management once all bulls have arrived at the sale site. IF A CONSIGNOR WISHES TO PLACE A HIGHER FLOOR ON THEIR BULLS THAT FLOOR MUST BE GIVEN TO SALE MANAGEMENT PRIOR TO SALE DAY.
- 10. Sale proceeds will be available immediately following the auction at the Turlock Livestock Auction Yard office.
- 11. Sale proceeds will be held if the consignor has not supplied sale management with proper paperwork: signed registration papers, semen evaluation forms, trichomoniasis testing results, and hauling slips.
- 12. Health Requirements:
- A. All Bulls must be semen tested by an accredited veterinarian or a NAAB or CSS approved technician. Semen test must be completed no more than 30 days prior to the sale. All semen test results must be turned into sales management by 5 pm on October 2nd.
- B. All bulls must be vaccinated for Anaplasmosis prior to the sale. Killed Anaplasmosis vaccine may be obtained through your vet or the California Cattlemen's office in Sacramento, 916-444-0845. The killed is a 2cc shot, one cc initially and the second cc three weeks later. Plan your schedule so this is done prior to the sale.
- C. All bulls must have a negative trichomoniasis test within 30 days prior to the sale.
- D. All cattle must be eligible for interstate shipment. Consignors are responsible for all tests that would be necessary for shipment outside of California. These tests would have to be completed after the sale and will be the seller's expense.
- E. Since there is not a formal veterinary health check all consignors will be responsible for guaranteeing the health of their bulls.
- 13. We encourage proper grooming of the bulls which includes removing any dead hair and shaving bulls heads. All grooming must be done prior to arrival. Turlock Livestock staff is not responsible for washing or grooming bulls.
- 14. Consignors are urged to have their trucks and trailers available on sale day, in the event thatcattle are needed to go their direction. Please check in with the office prior to leaving in case assistance is needed in hauling.
- 15. Consignors are urged to send photos and current weights on consignments for possible use in the advertising and/or catalog. Please make sure these photos are not taken from your cell phone and are of high resolution. For social media we can use photos from cell phones.
- 16.ALL ENTRY FORMS AND FEES MUST BE TO CELESTE BY AUGUST 23,2024. Entries may be emailed however payment must be received by August 23rd. Please plan accordingly. We want to be sure to have a nice catalog so that we can market your bulls to their highest potential possible. This takes time. Please be considerate and do your part to help meet deadlines.
